1. Account balance is due **NET 30 days** of the Statement date. Statements of Account will be sent at the beginning of each month for the month previous. Should *Customer* fail to meet account terms, the *Customer* hereby agrees to pay interest at the rate of 2% per month on accounts balances older than 60+ days.
2. The *Customer* agrees to pay by **e-transfer, EFT, or cheque**. If choosing to pay by credit card the *Customer* agrees to pay a **3% credit card processing fee** on the full outstanding balance.
3. The *Customer* agrees to authorize Dirt Dump Inc. to apply payment on overdue balances using the credit card provided and acknowledges there will be a **3% credit card processing fee** applied to the full overdue balance.
4. The *Customer* agrees to reimburse Dirt Dump Inc. for all expenses incurred in collection of payment on overdue accounts, including any legal costs and/or collection-agency fees.
5. The *Customer* agrees to pay NSF fees for cheques returned by your bank for insufficient funds.
6. Dirt Dump Inc. reserves the right to limit or terminate credit privileges at any time, and to raise or lower your credit limit without advance notice. The *Customer* will be notified if credit privileges are adjusted in anyway.
7. Dirt Dump Inc. is authorized to check references and obtain credit reports on the business and the principals for the purpose of obtaining information necessary to open the account or increase the credit limit.
8. The *Customer* grants Dirt Dump Inc. the right to report seriously delinquent charges to business and consumer reporting agencies and to provide information on the performance of this account with credit reporting agencies.
9. The *Customer* is responsible for providing Dirt Dump Inc. with any changes to business or owner information, required on this application, within 15 days (*i.e., address change, email address change, Accounts Payable contact change, etc.*)
